
• Which unmet public health need are you addressing?

Falls, pain and social isolation are conditions often unaddressed in a coordinated way, despite their high prevalence and severe consequences in older adults.



Approach to solve the problem

condition:

 pain: the most prevalent, costly and disrruptive of functional state health care

 social isolation: main mediator of cognitive, social and functional decline.
