Dr Anna Chioti is the Head of the Division of Pharmacy and Medicines (DPM) within the Directorate of Health / Ministry of Health Luxembourg. In this position, she is building the national regulatory capacity, while developing the legal and organisational framework of the future Agency for Medicines and Health Products of Luxembourg, focusing on innovative, adaptive and pragmatic regulatory schemes.

Medical doctor with a Master in Public Health and a Master in Business Administration, her field of expertise ranges from general clinical practice and preventive medicine, public health and environment, nutrition and clinical research to pharmaceutical and regulatory affairs. Her career track includes clinical experience in ambulatory and hospital setting, as well as several years in the pharmaceutical industry, where she led a wide portfolio of clinical studies, in all phases of development leading to market access, as well as the collection of real-life data.

Born Greek and Danish and educated in Belgium, she lives in Luxembourg since 2010, where she developed the Clinical and Epidemiological Investigation Centre within the Luxembourg Institute of Health. She managed to build a well-established research unit, bringing in expertise in pharmaceutical and regulatory affairs, while managing a growing clinical research team as well as numerous clinical research projects, in the fields of oncology, infectious diseases, nutrition, diabetes or cardiology.

Before joining the Ministry of Health, Dr Anna Chioti was leading the Department of Population Health of the Luxembourg Institute of Health, where she has supervised both operational and scientific staff, as well as students and interns, and has initiated, and developed several certified trainings and conferences to promote continuous medical education in Luxembourg.

She is an active member (and founding member) of several national healthcare strategic groups, boards of several professional and scientific societies in Luxembourg and internationally.

Dr Anna Chioti is a registered external expert for the European Commission (assisting in the evaluation of grant applications, projects and tenders, and providing opinions and advice in specific cases). She is also a former Scientific Committee Member of the EU Innovative Medicines Initiative (2016 - 2021).
